

OFFICE ORDER

The grant of 3<sup>rd</sup> financial up-gradation under the MACP Scheme to Dr N.S.Pandey, Assistant Director (Ballistics) CFSL, Chandigarh in PB-3 with grade pay of Rs 7600/- w.e.f 18.04.2011 was granted vide this Directorate order No DFSS/11/14/2009-Adm(FS)-420A dated 08.05.2012. However due to some administrative reasons, the said benefit was withdrawn with immediate effect and kept in abeyance vide this Directorate letter No DFSS/11/14/2009-Adm (FS)-507 dated 16.05.2012. The matter was thereafter referred to the MHA for examination and for obtaining their advice in the matter. MHA after examining the issue informed vide their ID No 25020/73/2015 PM-III(WS-III)(Part-II) dated 12.11.2018 that the Ministry has found that the said issue are not valid and therefore there are no grounds to keep the DFSS order dated 8.5.2012 in abeyance. It has also requested that the DFSS's Order dated 16.5.2012 may be withdrawn immediately and DFSS's orders dated 08.05.2012 may be restored with all benefits.

2. Accordingly Directorate letter No DFSS/11/14/2009-Adm (FS)-507 dated 16.05.2012 is hereby withdrawn with immediate effect and all the benefits for which the individual is entitled under the grant of 3<sup>rd</sup> financial up-gradation under the MACP Scheme to Dr N.S.Pandey, the than Assistant Director (Ballistics) CFSL, Chandigarh in PB-3 with grade pay of Rs 7600/- w.e.f 18.04.2011 is also hereby restored.

3. This issues with the approval of the Competent Authority at MHA as communicated vide their ID No 25020/73/2015 PM-III(WS-III)(Part-II) dated 12.11.2018.
